#### The Role

The successful candidate will be expected to work closely with other analysts and consultants of all disciplines across the organisation and in different world-wide locations, as required, to contribute to the delivery of highest quality consulting services to clients.

The position has no direct reports but will liaise with the other team members to ensure that the quality of information provided is consistent, of the highest quality and as complete as possible.

### **Overall Responsibilities & Specific Duties**

The successful candidate will be responsible for delivery of sound, practical LNG research data to Consultants, and shall:

- Be able to draft proposals, work orders, budgets and schedules with a clear understanding and interpretation of a client's RFP or summary of requirements
- Demonstrate a high-level understanding of management of client relationships and project delivery
- Be able to support project teams in project research, data input, information gathering, and report preparation with a high-level understanding of conceptual and strategic targets for reports
- Identify potential for scope-creep and avoid rework through clear understanding of scope of work
- Be able to work as a supporting team member across multiple projects and studies simultaneously
- Develop an understanding of prioritisation and application to successful completion of projects
- Contribute to group discussion to identify problems and effective solutions for timely execution and completion of projects
- Display capability to present concepts clearly and simply to audiences
- Provide analytical support in the development and application of proprietary quantitative models
- Achieve a detailed knowledge and understanding of the LNG business and develop a deeper knowledge of specific parts of the value chain
- Assist project managers in maintaining documentation for specific projects complete and up to date, including maintenance and upkeep of the Extranet
- Develop high-quality inputs as required and assigned for LNG Consulting quarterly forecast updates and the Global LNG Outlook report
- Develop and maintain a network of industry contacts through participation in industry gatherings, events, conferences or other means.
